

## Clearinghouse CDFI Honored by B Lab as 'Best for the World' 2021 for 4<sup>th</sup> Consecutive Year

Using Business as a Force for Good, Clearinghouse CDFI's honors include Best for Customers, Best for Governance, and Best for the World: Overall

LAKE FOREST, Calif., July 15, 2021: Clearinghouse Community Development Financial Institution (Clearinghouse CDFI) was recognized as 'Best for the World' 2021—for creating exceptionally positive impacts through its business operations based on an independent, comprehensive assessment administered by the nonprofit B Lab. This is the fourth consecutive 'Best for the World' honor for the company.

Clearinghouse CDFI was specifically honored as 'Best for Customers' and 'Best for Governance' based on the B Impact Assessment scores of more than 2,100 Certified B Corporations. The B Impact Assessment measures a company's positive impact on its workers, governance, community, customers, and the environment. B lab describes 'Best for Customers' as, "Setting the standard for serving customers. By providing high quality products and services, and engaging in ethical marketing, data privacy and security, and feedback channels you add value to customers' lives while supporting the greater good."

"Best for the World is a special program for the B Corp community, and we're thrilled to resume it after pausing the program in 2020 due to COVID-19," said Juan Pablo Larenas, Executive Director of B Lab Global. "This year's Best for the World companies are operating at the very top of their class, excelling in creating positive impact for their stakeholders, including their workers, communities, customers and the environment. We're proud of the community of stakeholder-driven businesses we've cultivated over the last 15 years; together we're marching toward our collective vision of an inclusive, equitable and regenerative economic system for all people and the planet."

The full B Impact Assessment evaluates a company's environmental performance, employee relationships, involvement in the local community, the impact a company's product or service has on those it serves, diversity, and more. Clearinghouse CDFI made the list for exceptional practices, including creating economic opportunities for low-income and underserved areas and its inclusive representation of low-income communities through diverse company Board and Committee membership.

"It's a testament to our team that we are receiving this award for the fourth year in a row—especially during a time when so many communities grappled with a global pandemic and recession. Our staff and investors work to create positive change in the communities we serve and to exceed our impact goals," said Douglas J. Bystry, Clearinghouse CDFI President and CEO.

In 2020, Clearinghouse CDFI financed 284 projects that created or retained 3,800 jobs; 51% were in areas of high unemployment. Clearinghouse CDFI loans created 1,137 housing units in 2020, 57% of which were designated as affordable. Clearinghouse CDFI also provided \$49 million in financing to minority / women-owned or controlled organizations.
